


Workplace Safety Index 2020: Leisure and hospitality

	Cost billions	Percent total	
1.	\$1.13	30.6%	Falls on same level
2.	\$0.57	15.6%	Overexertion involving outside sources (Handling objects)
3.	\$0.36	9.9%	Other exertions or bodily reactions (Awkward postures)
4.	\$0.33	9.1%	Falls to lower level
5.	\$0.33	9.0%	Struck by object or equipment (Being hit by objects)

The top five injury causes account for over \$2.73 billion in costs and represent 74.2 percent of total workers compensation direct costs for non-fatal claims with more than five days away from work in the leisure and hospitality industry.

Understanding top risks in the workplace is the first step to protecting your business. Did you know: Liberty Mutual SafetyNet™ has sophisticated technical resources to help prevent falls, overexertion, and many other leisure and hospitality-related exposures.

Scientific methodology: The 2020 Liberty Mutual Workplace Safety Indices are based on 2017 data from Liberty Mutual, the U.S. Bureau of Labor Statistics (BLS), and the National Academy of Social Insurance. BLS non-fatal injury data are analyzed to determine which events caused employees to miss more than five days of work, and then rank those events by total workers compensation costs.

Note: Falls on same level represent the top concern for Leisure and Hospitality. These injuries are often due to slipping on a wet surface and falling, which commonly causes sprains or strains across various body parts. Other exertions or bodily reactions is defined by the BLS as, "...generally resulting from a single or prolonged instance of free bodily motion which imposed stress or strain upon some part of the body. This category also includes the assumption of an unnatural position for a prolonged period of time."
